



QBRED Cash Back Promotion Terms and Conditions

Promotion	<p>QBRED Cash Back</p> <p>Racing Queensland is offering a cash payment of \$2,000 (plus GST) to any purchaser of a QBRED eligible horse (pursuant to the QBRED Terms and Conditions) from an Eligible Standardbred Yearling Sale (Applicant).</p>
Promoter	<p>Racing Queensland Board (trading as Racing Queensland) ABN 80 730 390 733 of Racecourse Road, Deagon, Queensland 4017.</p>
Promotion Period	<p>The Promotion starts January 28, 2024 and closes on May 1, 2024.</p>
Promotion Restrictions	<p>To be eligible for the Promotion:</p> <ol style="list-style-type: none">(1) The horse must be purchased from one of the following Eligible Standardbred Yearling Sales:<ol style="list-style-type: none">(a) APG Gold Coast Yearling Sale on January 28, 2024;(b) Sunshine Stars Yearling Sale on February 11, 2024;(c) Redcliffe Yearling Sale on March 24, 2024.(2) The purchase price of the horse must be \$7,500 (plus GST) or more.(3) The purchase of the horse must not be a buy back (i.e. where the breeder/vendor or a close relative to the breeder/vendor of the horse purchases the horse at one of the Eligible Standardbred Yearling Sales). This will be determined at Racing Queensland's sole discretion.
Entry Procedure and Payment	<p>To claim the Promotion, the Applicant must:</p> <ol style="list-style-type: none">(1) Complete and return the Application Form to Racing Queensland by no later than May 1, 2024. Applications received after this date will not be accepted;(2) Complete and lodge the relevant transfer of ownership forms through the Queensland Racing Integrity Commission (QRIC) by no later than May 1, 2024. <p>The Applicant must provide any further information or documents that Racing Queensland reasonably requires to consider the Application.</p> <p>The Applicants eligibility for the Promotion is subject to the Applicant obtaining approval of the transfer of ownership by the QRIC prior to June 30, 2024. If the transfer of ownership is not approved by the QRIC for any reason, the Applicant will not be eligible for the Promotion.</p> <p>Racing Queensland will obtain sale reports from each of the Eligible Standardbred Yearling Sales to verify the purchase of the horse relevant to the Applicant's Application for the Promotion.</p> <p>Racing Queensland may reject an Application for the Promotion for any reason that it deems reasonable in the circumstances.</p> <p>Upon completion of (1) and (2) above, Racing Queensland will pay the purchaser/managing owner (as identified in the transfer of ownership forms in the sum of \$2,000 (plus GST).</p>
