PROMOTION PERIOD

The Promotion starts at **8:00am** (AEST) on **Monday, 4 November 2024** and closes at **7:00pm** (AEST) on **Thursday, 5 December 2024**.

No entries will be accepted after this time.

ENTRY REQUIREMENTS & RESTRICTIONS

Entries are limited to residents of Queensland aged 18+ years or older at the commencement of the Promotion who love greyhound racing and want to be part of the ownership experience ("**Eligible Entrant**"). Entries will not be accepted from registered Queensland greyhound owners (unless more than 5 years has lapsed since ownership), trainers or other licensed industry participants (and includes their immediate family members).

Entrants must be Queensland residents and be able to travel to Brisbane to attend the event held on the Thursday, 5 December 2024 to be eligible to win a prize.

The Promoter will collect and use each Eligible Entrant's personal information for the purposes of:

 - (b) Greyhound Syndicate Removal Member Form https://qric.qld.gov.au/wp-content/uploads/2017/04/greyhound-syndicate-remove-member.pdf. This is to remove the winner's share in the greyhound that expires after one year.

Upon completion of each of the above 2 steps, the winner will receive an email from QRIC and the Promoter (to the email address provided in the Submission Form) confirming that he or she has successfully accepted the prize and the process to follow to claim the prize to own a greyhound for a year.
